Your attendance at these meetings will ensure that the collective voice of the group is heard from a majority of the membership, and that there will be a greater understanding of the contract.

As we draw closer to the summer, I would like to invite you to join us for our summer activities. On July 20th, we will, once again, be taking our friends from Camp

Allen to enjoy a day at the beach. We will have a cookout, dancing and all of the fun and activities that the beach provides. Our day at the beach operates solely on the generosity of Local 633 Volunteers, and is a great family day. We will also be holding our Annual Local 633 Golf Tournament on September 7th at the Oaks Golf Course in Somersworth, NH. The registration form is included in this newsletter. 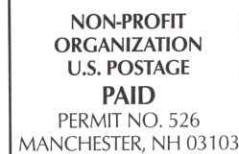
